A. A Visual Documentation of Fil-Hispanic Churches, Part XVI-A: Parish Church Complex of La Asunción de Nuestra Señora, Dauis, Bohol

Regalado Trota Jose focuses his visual documentation on a historical church that has undergone almost sixth renovations up to its present state. This church is known to have originally been established by the



members of the Society of Jesus (Jesuits), in which its earliest book of baptism reveals the active ministry of the Jesuits in the area since 1697. Upon the expulsion of the Jesuits in 1768, it was turned over to the Augustinian Recollects until 1898. It is unfortunate that this church was also damaged in big proportion by the recent earthquake of October 15, 2013.



Part XVI-B: Parish Church Complex of San Agustin, Panglao, Bohol

Panglao, Bohol has recently become known to many foreign and local tourists because of its beautiful white sandy beaches. It is a perfect getaway for people for rest and recreation. But much of the contribution to the beauty of Panglao is the historic parish Church of San Agustin. This church is historically known as under the administration of the Society of Jesus

and was eventually turned over also to the Augustinian Recollects in 1768 when the Jesuits were expelled. This town of Panglao has an affinity with the town of Dauis which both almost share the same life historically.

A. Hilary of Poitiers Makes East and West Meet: The Conciliatory Theology of De Synodis

Known as the Athanasius of the West, Hilary of Poitiers faced the burning dogmatic issue of his time – the Homousean controversy of the fourth century. **Jannel Abogado** who specializes in patristic sciences and teaches patrology at the ecclesiastical faculties of the University of Tomas, Manila, explores Hilary's *De Synodis*. It is the doctrinal reflection on the divinity

of the Son and his proper ontological relations to the Father. In this article, the author has the primary aim of analyzing the conciliatory points of Hilary between the western *homoeouseans* and the eastern *homoeouseans*.

B. Impresos Franciscanos Hispano-Filipinos, 1593-1699 (Part II)

The second part of the article of **Cayetano Sánchez Fuertes** continues to explore the Franciscans' (OFM) role and involvement in the field of early publication and dissemination of printed materials for the catechetical and religious instructions of the Filipino natives,



located in the Tagalog and Bicol regions. The author masterfully presents in this article the Franciscan contributions on the evangelization of the Philippine islands in the early life of Christianity through the use of archival and rare primary sources.

C. The Less than Ideal Care in the World of Health Care: Morally Relevant Considerations and Recommendations

From the perspective of a medical doctor and at the same time a religious sister, Maria Elena Adre, FdCC, tackles the modern moral/ethical complexities of health-care issues in this article. Such



complexities should remind health practitioners of the need to be enlightened by code of ethics and the official teachings of the Catholic Church. The ideal world perspective of the patient and doctor meeting the not-so-ideal realities of healthcare practice has become the staple discussion in bioethics as expressed by the author. The article serves as a moral compass for reflection for anyone involved in the conscientious healthcare profession.

D. Theologizing on the Arts: The Photo of the Child and Vulture

Can theology as a science exhaust the unfathomable meaning of an artwork? **Delfo Canceran, OP** dips his thought on the theologicophilosophical dimension of an artwork via photograph which has become a *cause celebre* to many people in the western hemisphere. In 1993, Kevin Carter went to Sudan to cover the state of suffering of the country due to poverty and tribal

war. Carter took a photo of a tiny child huddling on the ground and moving towards the feeding center. A vulture landed near the child lurking and preying her, which at that moment was photographed by Carter. The photo came out in The New York Times. It is so disturbing that some would not approve of it being published. But the picture says many things other than what appears on the photo even the uneventful suicide of the photographer.

The *Philippiniana Sacra* has recently qualified for the Commission on Higher Education (CHED) Accredited Research Journal Category A-2 (CMO No. 23, series of 2014). This is in pursuant to CHED Memorandum Order (CMO) No. 5, Series of 2012, *"Revised Guidelines for CHED Accreditation of Research Journals..."* The recognition takes effect from December 19, 2014 until December 2016. The classification allows the articles published in the journal to be classified as "international level publication."

The *Philippiniana Sacra* is the official publication of the University of Santo Tomas Ecclesiastical Faculties which started its publication in 1966. It releases three issues in a year. In 2016, it will celebrate its golden anniversary with a special edition dedicated to the Order of Preachers which will also celebrate its 800th foundation anniversary.

The Journal's current Editor is Rev. Fr. Jesús Miranda Jr., OP, with Rev. Fr.
